

**INVITATION TO BID: TILLAMOOK COUNTY
COMMUNITY HEALTH CENTER REMODEL

Tillamook County has acquired the Oregon State University Extension Service (OSUE) building located at 2204 4th Street, Tillamook, Oregon for use by the Tillamook County Health Department (HD). The HD intends to use the building for Administration Offices and Alternative Pain Treatment Services.

This project consists of general remodel and construction of the OSUE building. The bidder is responsible for all remodeling and construction work except for the installation of IT wiring upgrades and related components, which will be completed by the County.

(Allow two (2) workdays for reproduction of plans prior to them being mailed out to requesting contractors). Each prospective contractor must provide full company name, address, contact name, phone number and e-mail address at the time of request.

Bidders will not be required to be pre-qualified under ORS 279B.120. This contract is for a project that is subject to ORS 279C.800 to 279C.870 (Prevailing Wage Law).
