Bids are invited for the following scope of Work for this Project:

1. The completed work shall provide the Owner with one (1) new building and upgrades and additions to two (2) other buildings and related site work located within the WPCF plant site.

a. The upgrades and additions to the existing Administration/Operations Building work scope include a 15,071 Gross Square Footage (GSF) interior renovation and two new building additions comprising 2,543 GSF.

b. The upgrades and additions to the existing Maintenance Building work scope includes a 1,815 GSF interior renovation and a 9,041 GSF building addition.

c. The construction of new Water Quality Lab Building work scope consists of the construction of a new 8,486 GSF wastewater analytical laboratory.

d. Site work include the relocation of several process utility lines including but not limited to, Waste Activated Sludge (WAS), Secondary Scum Heavy Solids (SSM/HS), Primary Scum (PSM), Concentrate (CONC), and Process Drain (PD).
